EDC reached a record \$8.8 billion in business support for the cleantech sector, a 40% increase over 2021 This is in line with our efforts to build a more sustainable future for all Canadians.

And EDC solutions facilitated \$133 billion in export support and contributed to 3.7% of the national GDP – also an all-time high for Canada's official export credit agency.

These are merely snapshots of how we are moving the needle on our objectives, as we forge ahead with our 2030 strategy.

As our business has evolved, so too has EDC's leadership.
